Courts are being walked into our grassy areas and allowed to relieve themselves. This will be discussed at the next GC/CC meeting, and we are asking our residents ahead of time to please not take their pets into Colony Courts.

The GCLO Council has appropriated money to upgrade the playground areas this summer. Maintaining a safe and designated area for our children is a very important part of our community. The existing playground areas are in serious need of updating, not just for the pleasure of the kids but for safety purposes also. Two years ago we purchased a new piece of equipment to replace one that was falling apart, and this year the decision was made to forego new equipment and repair and repaint what is there already. Playground mulch will be used as a base for the area, holes in the merry-go-

placed, and existing equipment will be painted. The bench supports will be painted and the splintery and dangerous wood slats will be replaced with Trex 2 x 4's.

One more very special addition to the property will be the installation of a flag pole displaying the American Flag in the landscaped circle below the community building.

Winter and Icicles

Last winter brought exceptional amounts of snow and ice to the northeast, and Export was dealt a few inches short of recordbreaking amounts. While it was an especially beautiful winter, huge icicles hung from our roofs creating a potentially dangerous situation. GCLO Council has contacted gutter experts to get estimates on gutter helmets,

and electricians to get pricing on heat tape. This information will be shared with each unit owner, and they can therefore decide if they want to have this work done on their units **AT EACH UNIT OWNERS PERSONAL COST**.
