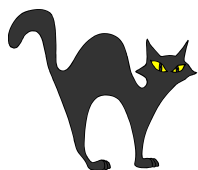

## Georgetown Curb Appeal

The Landscaping Committee, under the direction of the GCLC Council, is beginning to plan for updating the front landscaping of all units.

A walk-around was done and trees and bushes that were not in good shape, diseased, ugly, too close to other trees or buildings, or annoying in some way such as pine needles/sap dropping on cars and in walkways were marked for potential elimination, the thinking being to take out the scrappy stuff and start with a clean canvass.



Phase I is completed, and as we're moving into Phase II we need to get several bids so definite plans can be prepared for this phase and money allocated in the 2011 budget. NOTHING will be done without Council approval. This is just the beginning, and like the 15-year overall plan we need a good comprehensive guideline to follow to assure the job is done right!

ANYONE who wants to get involved and join the committee is most welcome. If you have any specific thoughts on this project - like, 'what the hell do you mean you might cut down some trees', please, talk to us. We don't know what you're thinking if you don't tell us. On the flip side, we DO NEED TO UPDATE for the sake of our property values. Our landscaping not only shows 'age' but is pretty ugly in many places! We'd rather have your input from the beginning than your complaints after the fact.

A lot of research and planning will be going into this so good design and financial decisions can be made, and this project can be completed in a timely and professional way. For our property value, this needs to be done as we are very outdated. Following is a tentative plan which can hopefully be coordinated with other projects such as fence replacement.

**Phase I:** Remove dead vegetation from Georgetown's common area—Completed: 9/1/10  
**Phase II:** Remove unsightly/old/unhealthy trees and bushes - Spring 2011  
**Phase III:** Trim trees and bushes— Fall 2011  
**Phase IV:** Get designs and quotes from landscaping professionals— Winter 2011  
**Phase V:** Discuss when and how to implement landscaping plan - Spring 2012  
**Phase VI:** Implement Landscaping Plan—Spring 2013
