All decorations must be consistent with the current holiday.

Decorations shall not be attached to the outside of the building structure or any fences

The Unit Owner is responsible for any damage done to the exterior of the building and/or to the shrubs and trees abutting the unit.

 ${f E}$ lectrical wires may not be placed in the lawn or walk areas.

Decorations must be removed 30 days after holiday.

The walks, entrances, and all of the Common Elements must not be obstructed, encumbered or used for any purpose other than ingress and egress to and from a Unit.

 ${f N}$ o objects are to be hung on the light fixture.
