## GCLO RULES AND REGULATIONS



- 4. General Rules and Use Restrictions
- 4.1 The walks, entrances, and all of the Common Elements must not be obstructed, encumbered, or used for any purpose other than ingress and egress to and from a Unit.
- 4.2 The personal property of all Unit owners shall be stored within their Units. Outdoor furniture is permitted only on the patio/porch surfaces.



Please remove plants/planters not in approved areas according to GCLO rules. Personal items are allowed on porches and within fenced areas only. They cannot be placed in driveways or other entrance areas according to Rules shown above.

Tom, Ladd and JP did a walk-around and letters will be sent to those not in compliance with GCLO rules on assorted issues. It would be most appreciated if each unit owner corrects the offense described in the letters. Council and the Rules Committee have to follow and enforce the rules with consistency among all unit owners. Thanks for all the cooperation from unit owners, Georgetown is looking great!
