



The origin of Welcome Lights leads back to ancient I reland, an indication of legendary I rish hospitality for weary travelers. In the days when it was illegal to practice the Catholic faith in I reland, the candle in the window told traveling priests where they were welcome and

could offer the I rish Catholic Mass in safety.

The U.S. origin of Welcome Lights leads to the pioneer days, when homes were spread far apart, the candle in the window meant that any traveler was welcome. Many lives are said to have been saved by the faint glimpse of a candle's glow through the swirl of a blinding storm. The window candle signifies the pioneer hearth - the center of activity and the heart of the home, providing warmth and a way to prepare food. It provided a place for family and friends to gather, young and old watching the dancing flames as they told stories and passed the cold winter nights.

Back patio lights are being replaced a few at a time. Curly Cue fluorescent light bulbs are put in them so you can leave them on 24/7 and it will only cost you less than \$2.00 per year. If you do the same with your front lights, Georgetown **would look especially nice this Holiday Season...... and all** year around too.
